I wish to receive music lessons for 2019/2020 and in agreeing to receive the lessons, I confirm:

- 1. I will ensure I have an up-to-date peri music timetable and attend lessons regularly and promptly.**
- 2. I will check for any changes to my peri music lesson timetable or venues by referring to the Peri Music Board weekly by Malley staff room, A01 Music Room and Assembly Notices.**
- 3. I will complete all practise work given by my peri music teacher at home.**
- 4. I will take personal responsibility to catch up on all work and homework from the subject lesson I missed whilst taking my peri music tuition.**
- 5. I will adopt the same codes of conduct and behaviour towards my peri music teacher as I would during my subject lessons.**
- 6. I will taking full responsibility and initiative to advise my peri music teacher of any planned school trips, Life Ready Days, the Athletic Championship Day and any school rehearsals/productions I am involved in that conflict with my peri music lesson.**
- 7. If I am absent from school on the day of my peri music lesson or do not attend (for whatever reason), this lesson will not be made up by the peri music teacher.**
- 8. If the peri music teacher is absent for any lesson, such lesson will be made up if possible or an appropriate refund given at the discretion of that peri music teacher.**
- 9. If I do not attend 2 or more peri music lessons, I will receive a formal verbal warning and my parents will be advised.**

**10. If I do not attend 4 or more peri music lessons, Alderbrook School reserves the right for me to be removed from the Peri Music Programme.**

**11. If I am late for my peri music lesson, my peri music teacher has the right to refuse teaching me on that lesson as my lateness impacts on the other students timetabled for that day.**

**- £122.75 by 8 November 2019 and**  
**- £122.75 by 2 March 2020.**

**3. If my child wishes to withdraw from the Peri Music programme during the year, a half term's notice is required. The deadlines for notice of withdrawal are:**  
**- 28 October 2019 to withdraw at the end of the Autumn Term**  
**- 17 February 2020 to withdraw at the end of the Spring Term.**  
**Payments will still have to be made for the entirety of that term.**

**4. To notify the Music Administrator, Alderbrook School immediately in the event of any issue or complaint with regards to the lessons.**
